Save the Date For Our 74th Annual Meeting of the Members

Our 74th Annual Meeting of the Members will be held on Wednesday, October 19, 2016

Nominations are Open for the Board of Directors

The Nominating Committee will be accepting packages for consideration beginning June 21, 2016.

The timeline for this year's Annual Meeting and Elections are as follows:

- JUNE 21: The Chair appoints a Nominating Committee of 3 or more members.
- JULY 21: The Nominating committee files all nominations with Secretary of the Credit Union.
- AUGUST 4: The Secretary of Credit Union announces nominations. Nominations for vacancies may also be made by petition signed by 1% of the members with a minimum of 20 and a maximum of 500.
- AUGUST 29: Nominations by petitions close.
- SEPTEMBER 6: Nominations by petition must be filed with the Secretary of the Credit Union.
- SEPTEMBER 14: The Secretary of the Credit Union, posts in a conspicuous place at the Credit Union all nominations by petition along with those from the Nominating Committee.

Members not nominated by the Nominating Committee have the right to become candidates "by petition signed by 1% of the members" {Article V, Section 1(b)}; given the size of the membership on July 31st, 2016, the estimated minimum number of required member signatures is 128.

A petition form, as well as the required forms that need to be submitted with the completed petition, are available from Debbie Crowson at: dcrowson@coopfcu.org, and or Fadhila Holman, CEO, at: fholman@coopfcu.org. Documents that are required {Article V, Section 1(c)} to be submitted along with the petition are:

- 1. A Bio/Statement of Qualifications, 250 words or less
- "a signed certificate from the nominee or nominees stating that they are agreeable to nomination and will serve if elected to office"
- Authorization for background check, NCUA Application, Form 4063a, other forms and supporting documentation as required by the National Credit Union Administration (NCUA)

The above must be submitted no later than 5:00 p.m. on August 29, 2016 to the following address:

Please note: Petition signors must be 18 years old, a primary member on a natural person share account and in good standing to validly sign a petition or to be elected to the Board. For Non-Natural Person members, such as businesses or organizations, signatures (the same as official ballots) must be accompanied by an official designation of voting rights for the organization (one member/one vote). Petition signatures will be validated by the Teller of Elections (League of Women Voters).





Have you thought about what will happen to your favorite businesses and their employees when the owners retire?

Did you know that retiring baby boomers own two out of every three U.S. businesses with employees? Have you thought about what will happen to your favorite businesses and their employees when the owners retire? Succession planning is a real need for companies today, as only a fraction (15%) of family-owned businesses have kids who want to take them over. It can be devastating for communities when these long-standing, locally rooted businesses close or are sold to out of town buyers that relocate or cut jobs. But there can be another way.

The Island Employee Cooperative is the story of three locally owned shops that have served a community for 43 years. These stores meet the neighborhood's basic needs for grocery, gas, hardware and pharmacy.

They still exist today as vibrant local businesses because when the long-time owners retired, they sold the business to the employees. It happens to be in Maine, but could be in our neighborhood.

In 2014, Vern and Sandra Seile wanted to sell their business and retire, but worried that an outside buyer would consolidate operations and cut jobs. Many of their 60 employees had worked with them for several decades and they had formed a close community with their customers. By selling the shops to the employees, not only did the Seiles save 60 jobs, they gave their employees access to business ownership. In addition, the Seiles were able to get a fair price and take advantage of substantial tax benefits for becoming employee owned.

Employee ownership doesn't just sound good; it creates strong local economies. Studies show that employee owned businesses deepen impact in communities by increasing job quality and stability, investing locally and having a positive impact on job creation and business retention.
